4.1 Description of first aid measures	
General information:	
After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.
After skin contact:	Remove contaminated clothing immediately. Wash with plenty of water. Consult a physician.
After eye contact:	Immediately flush eyes with plenty of water for at least 15 minutes. consult a physician.
After swallowing:	Rinse mouth with water. Immediately after ingestion Never give anything by mouth to an unconscious person. Do not induce vomiting. Consult a physician.
4.2 Most important symptoms and effects, both acute and delayed:	The most important symptoms of caprylic acid exposure include acute irritation of the skin, eyes, and respiratory system, while delayed effects may involve persistent skin dryness, allergic reactions, or respiratory issues with prolonged exposure.
4.3 Indication of any immediate medical attention and special treatment needed:	Treat symptomatically.

5.1 Extinguishing media:	Water, Carbon dioxide dry powder

5.3 Advice for firefighters:	Wear fully protective suit, safety glasses and respiratory device. Cool tanks/drums with water spray/remove them into safety.

6.1 Personal precautions, protective equipment and emergency procedures:	Use personal protective equipment. Avoid breathing vapors, mist or gas. Ensure adequate ventilation. 6.3 Methods and material for containment and cleaning up:	Take up spill into absorbent material, e.g.: sand, earth, vermiculite, powdered limestone. Scoop absorbed substance into closing containers.
