General information:	
After inhalation:	If breathed in, move person into fresh air. If not breathing, give artificial respiration. Consult a physician.

4.2 Most important symptoms and effects, both acute and delayed:	The most important symptoms and effects of N-Acetyl-L-Cysteine (NAC) exposure include acute gastrointestinal discomfort (nausea, vomiting, diarrhea), skin irritation, and potential respiratory issues, with delayed effects possibly involving liver strain or exacerbation of pre-existing respiratory conditions.
4.3 Indication of any immediate medical attention and special treatment needed:	Treat symptomatically.
