Inhalation:	can cause respiratory irritation, dizziness, headaches, and long-term exposure may lead to more severe health effects, including liver and kidney damage.

Skin Contact:	can cause irritation, redness, and drying of the skin, and prolonged exposure may lead to more serious skin damage or absorption into the bloodstream.
